

Summary of Capacity Credits Assigned by Facility for the 2022 Reserve Capacity Cycle

For the Capacity Year from 1 October 2024 to 1 October 2025

The Australian Energy Market Operator (AEMO) has assigned Capacity Credits to Facilities that must provide Reserve Capacity into the South West Interconnected System for the 2024–2025 Capacity Year. Following the assignment of 4,596.425 MW of Certified Reserve Capacity, a total of 4,596.425 MW of Capacity Credits were assigned.

In accordance with clause 4.1.15A of the Wholesale Electricity Market Rules (WEM Rules), AEMO publishes the following information:

- AEMO has secured sufficient Capacity Credits to meet the Reserve Capacity Requirement of 4,526 MW.
- No Certified Reserve Capacity was assigned under the Early Certified Reserve Capacity provisions of clause 4.28C of the WEM Rules.

In accordance with clause 4.20.5A(b) and clause 10.5.1(f)(iv) of the WEM Rules, AEMO publishes the quantity of Capacity Credits assigned and the Facility Class for the 2024–2025 Capacity Year in the table below.
